A Few Quick COVID-19 Updates

- Governor Steve Sisolak has rolled out the Nevada United: Roadmap to Recovery Phase 1 Statewide Standard Guidelines and Protocols for Individuals and Businesses [HERE](#). We will see some businesses permitted to re-open with restrictions beginning on Saturday, May 9th, at 12:01 a.m. As more specific industry guidance becomes available, it will be posted on the Nevada Health Response website [HERE](#).
- The Nevada Division of Industrial Relations (DIR) has released a letter that outlines the steps your business should take as our state's economy slowly comes back to life. This letter provides guidance on updating your safety plans and training processes. Click [HERE](#) to learn more.

- The Federal Reserve Board has announced expansion of the Main Street Lending Program [HERE](#), which would offer four-year loans to eligible companies employing up to 15,000 workers or with revenues of less than \$5 billion. Principal and interest payments will be deferred for one year.
