City of Reno Small Business Economic Assistance Program

The City of Reno has unveiled its Small Business Economic Assistance Program, funded with federal CARES Act dollars. And your team at NAIOP was heavily engaged with city staff and helped to craft the program. We wanted to focus on those businesses that have been forced to close multiple times due to Governor Sisolak's proclamations, especially bars, taverns, and distilleries. Nevada Commercial Rental Assistance Grant Program Application Deadline Extended

The [Nevada Commercial Rental Assistance Grant \(CRAG\)](#) program is still open and accepting applications. It will provide up to \$10,000 to eligible commercial tenants. Residential Eviction Moratorium Extended

On Monday, Governor Sisolak announced that he is extending the residential eviction moratorium an additional 45 days (through October 14, 2020). He stated that this will allow for more federal funds to flow to renters, more time for the court system to implement the newly-created mediation program, and more time for the state's unemployment system to reduce the backlog of claims.
