### NDEP Grants Available Replace Diesel Fleets and Equipment

The Nevada Divisions of Environmental Protection (NDEP) is offering Nevada businesses up to \$8 million in Volkswagen Settlement grants to help replace diesel-powered vehicles and equipment - including freight trucks and delivery trucks - with low and zero-emission alternatives to reduce air pollution and support a healthy, sustainable Nevada.
